

WorxEstate and LIFE expand partnership with Sneeuwbeslaan project

Antwerp, 7 July 2026 – WorxEstate, the real estate arm within investment company WorxInvest, is expanding its strategic partnership with Antwerp-based real estate developer LIFE with a second project. Together, both parties have acquired the office building at Sneeuwbeslaan 14 in Antwerp. WorxEstate previously announced a partnership with LIFE to redevelop the [Havenbuilding](#) on Antwerp's *Eilandje* district.

With the acquisition of Sneeuwbeslaan 14, WorxEstate and LIFE confirm their ambition to further develop their partnership in the coming years through joint investments in strategic real estate locations in Belgium.

The existing building, covering approximately 11,000 m², will retain its office function in the short and medium term and will continue to be professionally managed. At the same time, both partners will explore opportunities for future redevelopment, in line with their shared long-term vision for transforming strategically located real estate assets.

"Following the Havenbuilding, this is a logical next step in our strategic partnership with LIFE," says Cedric Dierckx, CEO of WorxEstate. "By combining our financial strength with LIFE's development expertise, we are creating long-term value for locations with strong transformation potential."

"With Sneeuwbeslaan, we confirm that our partnership with WorxEstate is more than a one-off project. Together, we are building a long-term platform in which active management and future redevelopment reinforce one another," says Toon Haverals, Managing Partner of LIFE.be.
